All homeowners must have guests depart, and doors locked on or before 12:00 midnight.

All deposits must be paid by check or money order. No cash will be accepted. Please make all checks or money orders payable to: Sundown Homeowners Association.

Separate checks or money orders must be written for the deposits. The clubhouse rental fee (non-refundable) is \$75.00. A refundable deposit (cleaning and damage repairs fee) is \$300.00 which will be returned upon receipt of all key(s). Homeowner agrees not to have any duplicate keys made. After inspection of the clubhouse and common areas surrounding the clubhouse (including the pool area, bathrooms) the deposit will be returned if the entire area is clean, all rules have been followed and the clubhouse, grounds, pool area, bathrooms and any common area Association property are found to be undamaged. A final inspection will be made when the keys are returned to a Board Member. Any key(s) not returned will be deducted from the refundable deposit at cost, plus a service charge of \$25.00, to have keys remade. If any damage exceeds the cost of the deposits, the homeowner agrees to be charged accordingly and it will be put on the owner's account, along with the association dues owed, on their monthly billing. Homeowner agrees to pay the damages in a prompt manner.

<u>Only</u> homeowners may rent the clubhouse. Tenants must submit written, signed permission from the owner and provide a copy of their lease. All persons renting the clubhouse will be required to show proof of residency with a photo ID.

No extension cords may be used, power strips are allowable.

Exits/entrances cannot be blocked (ie: tables, chairs, etc.) at any time.

No live bands, or DJ's or amplifiers are allowed. CD players, record players, boom boxes or radios are allowed, however, no audible noise or music heard from outside the

clubhouse will be allowed. Please be considerate to all surrounding neighbors. **No noise** or music allowed after 10PM.

<u>In accordance with Nevada State Law, no one under the age of 21 will be served an alcoholic beverage while on the premises.</u>

Bathrooms, clubhouse, pool area, clubhouse grounds must be cleaned including floors, toilets, sinks, walls, etc. of any food, drink, decorations or dirt, etc.

All decorations must be <u>completely</u> removed, including staples, thumb tacks, scotch tape or masking tape.

All trash, including food, beverage cans, party decoration, etc. must be removed to the homeowners residence. No trash will be allowed in the existing clubhouse or pool trash cans.

All children must be supervised at all times. All children 14 or younger must be supervised by an adult, age 18 or over.

No running or horseplay will be tolerated at any time in the pool area or common areas.

Any illegal substance activity by anyone or alcohol given to minors (possession, usage, sale, etc.) will result in the *immediate revocation and denial* of any future requests for any Association amenities. The homeowner will have the opportunity to have a hearing before the Board according to NRS116.
